5 years after W.Va. mine blast, safety and explosion issues persist

CHARLESTON, W.Va. — The nation's worst coal mine disaster in decades exposed lax safety measures at some Appalachian mines, issues that persist five years later despite the crackdown that followed, according to an Associated Press review of federal inspection records.

Excess methane gas and flammable coal dust fueled a fireball that raced through the Upper Big Branch mine in southern West Virginia on April 5, 2010, killing 29 men. The explosion and mass casualties rocked the mining community, which had just recorded its safest year ever in coal mines.

# International Nutrition to Pay \$78,000 in Omaha Plant Collapse-

**OMAHA, Neb.** – A livestock feed company has agreed to pay \$78,000 in penalties related to last year's collapse of International Nutrition's Omaha plant that killed two workers.

The Labor Department's Occupational Health and Safety Administration announced the settlement Wednesday. Originally, regulators had sought nearly \$121,000 in penalties.



## Tonya Ford, Deputy Director & Secretary (Lincoln, NE)



Tonya became an active member and advocate for workplace safety after the death of her Uncle Bobby (Robert Fitch) in January 2009 and was appointed USMWF's Deputy Director in February of 2015.

Uncle Bobby fell 80ft off of a belt-operated man-lift in a local Archer Daniel Midland Plant (ADM) that he had worked at for over 30 years. His brother in -law found him that day and stayed by his side while the paramedics did everything they could do to help him however, Uncle Bobby could not be revived at the scene and was pronounced dead a few minutes later at the near by hospital.
